

VIDEO SURVEILLANCE

INFORMATION ON THE PROCESSING OF PERSONAL DATA UNDER REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND COUNCIL

Pursuant to and for the purposes of Article 13 of Regulation (EU) No. 2016/679 (hereinafter "GDPR"), as well as the Provision of the Guarantor for the Protection of Personal Data on Video Surveillance of April 8, 2010, we inform you that the personal data you voluntarily provide to ITALO - Nuovo Trasporto Viaggiatori S.p.A. (hereinafter referred to as the "Data Controller" or "Italo") will be processed in compliance with current legislation on the protection of personal data and, in any case, with the principles of fairness, lawfulness, transparency, and respect for your rights.

1. Categories of Personal Data Processed

Italo will process images related to your person.

2. Purpose, Legal Basis for Processing, and Legitimate Interests Pursued

The use of cameras is aimed at protecting the safety of Italo's personnel and individuals accessing video-monitored areas, as well as safeguarding the company's property and assets from potential assault, theft, robbery, vandalism, and other illegal activities. In any case, your personal data will be processed without the need for your consent, pursuant to Art. 6(1)(f) of the GDPR, for the pursuit of the legitimate interests of the Data Controller.

3. Method of Processing

Individuals will be appropriately notified of the presence of image detection and recording systems through signage placed in the vicinity of video surveillance areas, in accordance with Annex 1 of the General Order of April 8, 2010. Images are captured exclusively by specially trained personnel responsible for supervising company premises and are recorded and stored on the company server. Access to recorded images is restricted exclusively to personnel authorized by the Data Controller.

4. Recipients or Categories of Recipients of Personal Data

The images are not communicated or disseminated outside the Data Controller's facility, except as part of investigative and security activities at the request of authorities and/or the judicial police.

5. Criteria for Data Storage

The data concerning you will be retained for a period of 7 days for territorial sites and 24 hours for onboard trains, following which it will be deleted or overwritten, subject to specific requirements for extended storage if requested by authorities and/or the judicial police.

6. Privacy Rights of the Data Subject

You have the right to exercise, at any time and within the limits set forth in Articles 15-21 of the GDPR, the following rights concerning your data:

- Access (Art. 15 GDPR), including the right to obtain a copy of your personal data, provided that the rights and freedoms of others are not affected;
- Rectification (Art. 16 GDPR);
- Erasure (Art. 17 GDPR);
- Restriction of processing (Art. 18 GDPR);
- Data portability (Art. 20 GDPR), meaning the right to obtain from the Data Controller data in a structured, commonly used, and machine-readable format for transmission to another Data Controller, if technically feasible;
- Objection to processing (Art. 21 GDPR).

We remind you that pursuant to Article 77 of the GDPR, you may lodge a complaint with the Guarantor Authority in case of violation of the current legislation on the protection of personal data, following the procedures and directions published on the Authority's official website at www.garanteprivacy.it.

7. Data Controller, Data Processors, and Data Protection Officer

The Data Controller of your data is ITALO - Nuovo Trasporto Viaggiatori S.p.A., with its registered office in Rome (RM), Via Casilina 1, in the person of the legal representative pro tempore.
